Pursuant to Article 34, item 19, and Article 71, paragraphs 1 and 2 of the Statute of the University of Rijeka (CLASS: 030-01/25-01/07, REG. NO.: 2170-137-01-25-1 dated March 28, 2025), and based on the proposal of the Expert Council for Teaching and Learning and with the consent of the Assembly of the Student Union of the University of Rijeka (CLASS: 007-01/25-01/09, REG. NO.: 2170-137-01-25-25 dated April 9, 2025), the Senate of the University of Rijeka at its 107th session held on 14 April 14 2025, has adopted the following:

DECISION

on the amount of enrolment fees and the designated allocation of the funds in the academic year 2025/2026

GENERAL PROVISIONS

I

- (1) This Decision determines the amount of enrolment fees and the designated allocation of the funds from enrolment fees at the University of Rijeka and its constituent units for the 2025/2026 academic year.
- (2) The enrolment fee referred to in point 1 of this Article does not include other material costs associated with a specific study programme (e.g. health or sanitary checks, occupational safety, artistic or working materials, etc.), which are determined separately by the programme provider and stated in the call for applications.

AMOUNT OF ENROLMENT FEES

- (1) The enrolment fee for admission to the first year of study is EUR 55.50.
- (2) The enrolment fee for all other types of enrolment (enrolment in a higher year, repeat enrolment in the same year, or enrolment in another study programme within the same constituent unit) is EUR 40.00.

DESIGNATED ALLOCATION

- (1) Funds collected from enrolment fees shall be allocated for the following purposes:
 - Improvement of student standards (through strategic and programme activities)
 - Coverage of material enrolment costs

OBLIGATION TO PAY

IV

- (1) The enrolment fees outlined in Article II of this Decision are payable upon enrolment in the first year, in higher years of study, upon repeating a study year, or when enrolling in another study programme within the same constituent unit.
- (2) The obligation to pay the enrolment fee does not apply to:
 - Students who, as of 29 December 2020, resided in areas affected by the earthquake and held residence in Sisak-Moslavina County, with buildings designated as N1/N2 or PN1/PN2 (usable) based on a preliminary damage assessment by a certified structural engineer, in accordance with the methodology of the Croatian Centre for Earthquake Engineering (supported by recent proof, e.g. a certificate from the Civil Protection Headquarters);









- Students from Ukraine who have been granted temporary protection in accordance with the Government of the Republic of Croatia's Decision of 7 March 2022 and its extension of 27 February 2025.
- (3) In justified cases, and at its own expense, a study programme provider may issue a special decision exempting an individual student or a specific category of students from the enrolment fee.

FUND CALCULATION

- (1) After the enrolment process is concluded, the study programme providers shall submit data to the University on the number of enrolled students for the 2025/2026 academic year and the number of students exempt from the enrolment fee as defined in Article IV, paragraph 2.
- (2) Based on this data, the University shall calculate the designated allocation of funds for the improvement of student standards in accordance with this Decision.
- (3) Following the calculation, study programme providers shall transfer the corresponding funds for student standard improvement to the University within the specified deadline.

FINAL PROVISIONS

This Decision shall enter into force on the day of its adoption and shall be published on the official websites of the University and its constituent units.
